Message from the Board

Following a Commissioned Officer Student Training and Extern Program (CO-STEP) experience the summer of my junior year in dental school I was given a book entitled "Plagues and Politics" signed by the Surgeon General Antonia C. Novello, MD, MPH. The book covers the events leading to the creation and evolution of the U.S. Public Health Service, the National Institutes of Health, and other agencies with the mission of population health. Stimulated by current events to re-read this book, it is notable that repeatedly over the years attempts to mitigate the impact of potentially catastrophic infectious diseases have had divisive results as paraphrased below:

"Quarantine became the battleground for contending the forces of federal public health expansion. . ." impacting on the economy, immigration, and state vs federal authority. The evolution of the health professions themselves has been shaped by these events.

Today history is again repeating itself, with mandated social distancing resulting in restrictions in travel, "stay at home" (quarantine) orders, masking mandates, and adamant debates on individual rights and state vs federal responsibilities.

The dental profession and our specialty of Dental Public Health have not been immune—dental clinics have been shuttered, and the impact on practicing dentists and those in training who have been unable to complete their educational programs face an uncertain future.

The Board had planned for the largest number of candidates in our history to challenge the examination. There were 34 candidates approved to take the written examination and 19 scheduled to challenge the oral portions of the exam. As with other facets of education, the pandemic is challenging our traditional approaches. The Board has been creative in exploring alternatives to in-person testing; 16 candidates have undergone the oral examination via videoconference. The Board also solicited quotes from several vendors offering online solutions for administering the written examination. It is the Board's goal to serve our candidates while balancing their safety and maintaining the rigor of the certification process.

Thank you for your continued support as we exercise an abundance of caution in this current environment.

Mission Statement for the American Board of Dental Public Health

In anticipation of the upcoming 10-year review of our specialty, the Board crafted a mission statement derived from a passage in the original articles of incorporation:

"The purpose of this corporation shall be to protect and improve the public's health by the study and creation of standards for the practice of dental public health in all its aspects and relationships and to grant and issue to duly licensed dentists, certificates of special knowledge and ability in preventive dentistry and dental public health."

The statement reads:

"The mission of the American Board of Dental Public Health is to protect and improve the public's health through the study and creation of standards for the practice of dental public health in all its aspects and relationships, and to grant and issue certificates of special knowledge and ability in dental public health to dentists."

We look forward to working with AAPHD to prepare the submission for the 10-year review of the specialty this coming year.

Examination Changes

The National Commission on Specialty Recognition approved two changes in the pathway to certification: the Alternate Pathway and the Qualifying Examination.

Both of these changes help align the ABDPH with other specialty organizations and are endorsed by the Commission.

We Welcome Your Contributions

We currently have 166 active Diplomates, not including 60 life members. We are a growing specialty with a developing international representation. Since 2014, the number of candidates who challenged the examination has doubled, resulting in a 25% increase in Diplomates during the past five years.

Since 2019, the Board has worked to increase the capacity to accomodate larger numbers of candidates seeking to challenge the examination. This increase was made possible by the generous gift of time from past presidents who served as guest examiners.
